## a) President - Danielle

## c) Scheduler- Joy

- Majority of the teams did a good job getting their game reports in
- In regards to social media, there has been some glitches with updating
- Some changes for this season, with game reports league is asking for a MVP of the opposing team as well as any notes of the game such as referees, or games out of control, and summary off matches
- Prize for most valuable player at year end tournament

## d) Registar- Char

- 175 Registered players for the 2022-2023 season
- Most signed on time with only 8 late registrations
- BC Soccer has updated the format on how to upload registered players
- Biggest concern in regards to registering players was formatting and including all required information
- Any registrations after September are considered as a late registration
- Have another meeting late August to address the registration process so teams have a better understanding
- There's a discussion in regards to including a code of conduct when registration to ensure appropriate conduct on the soccer field

- Can we impose our own age restrictions within our league
- We are a recreational adults league that is inclusive and accessible for all
- Players need to be aware and understand the BC

#### 5. Elections- Danielle

#### 6. New Business- Danielle

## a) Campbell River request

- Request from Campbell River to be entered into the league which would bring MIWSL to 8 teams

## b) League fees

 Same as last year, \$200 per team plus \$50 per team for BC Soccer and \$34 per player for insurance

## c) Start and end dates

- Games are scheduled on Sundays
- Start date is September 10, 2023 to December 10th which is last game before winter break
- January 7th, 2024 we return to game play until our last game March 10th 2024

## d) Tournament date and location

- Date of tournament will be Saturday March 16th, 2024
- Some chatter about moving to the last weekend in March to make room for make-up games as well as Spring break conflicts. Tricky with busy family schedules
- Port Alberni and Nanaimo Thrive are due to host year end tournament
- Nanaimo Thrive stepped up and are hosting our year end tourney

## e) Jewelry

- Piercings and location on the body
- Referees are quite forgiving
- Ross head referee in Nanaimo suggested if we want them to be lenient, our league must have a safe rule in place
- Clear guidelines from the league are key
- Suggestions like taping or covering
- Executive must create the language around this
